## **NBCI Demands Chief Jackson to be Fired and County Attorney Bob McCulloch to Step Aside**

### *Ferguson Demands Public Servants Who Can Deliver Justice*

**Washington, DC** – The National Black Church Initiative (NBCI), a faith-based coalition of 34,000 churches comprised of 15 denominations and 15.7 million African Americans, is calling for two of Ferguson’s public servants to be removed based on their inability to deliver impartial justice to the citizens they serve. Chief of Police Thomas Jackson’s conduct in the course of a felony investigation and County Attorney Bob McCulloch’s blatant biases render them incapable of continuing their duties in a professional and ethical manner.

Rev. Anthony Evans, NBCI President noted the reality that “Both of these officials have demonstrated a pattern of racial insensitivity towards Ferguson’s African American residents. You cannot get any justice in Ferguson unless you are white. This is why we join the chorus of those around the world asking for the Chief of Police to be fired and the County Attorney to step down.”

NBCI is disheartened to see yet another display of what is wrong in America when it comes to race. These types of individuals simply do not care for black people, carrying a sense of white supremacy that automatically assumes that every black man is guilty of a crime and is inferior to their intellect.

For justice to be delivered to Michael Brown impartiality and fairness must be realized. Sadly, what exists now is a criminal justice system that amounts to little more than a lynch mob in Ferguson County. Historical data of whites and blacks in Ferguson’s criminal justice system illustrates a strong, lingering bias against African Americans. The United State Department of Justice must stay the course and launch a comprehensive forensic criminal analysis of Ferguson county to help the community heal and justice to be served fairly to all.
