## **The National Black Church Initiative Calls upon all Black People of Baltimore to have Faith in District Attorney Mosby and Leave that Sister Alone**

*She is fighting against wickedness and Principalities*

**Washington, DC** – The National Black Church Initiative (NBCI), a faith-based coalition of 34,000 churches comprised of 15 denominations and 15.7 million African Americans, is humbly pleading with our brothers and sisters of Baltimore and across this country to extend faith and your prayers for District Attorney Marilyn Mosby. This sister is fighting against principalities and wickedness in high places as she tries to break down the blue steel wall of corruption that is hiding five murderers. Justice, when fighting wickedness and a judge who is trying the case for the Defense, takes time. God is not finished with revealing the depth of the evil that exists behind the death of Freddie Gray. Our brother was a saint who came to earth to do his job and he died in a way that his life would leave an imprint on the souls of those that killed him, on the souls of those who are defending him and loved him and on the souls of those who seek justice on his behalf.

This sister is putting her all on the line, because when you go against the system that is rigged against Blacks and the poor, and continues to oppress those who are not in the loop, you are going to run into a steel resistance that is built on lies, distortion and a wink-wink. We must give this sister some time to work this out. The entire State of Maryland Judiciary is using all undue

pressure on her and her office and members of her staff, not to win this case because they do not want to set a precedent or expose the level of corruption that has always existed within the Baltimore law enforcement community.

Rev. Anthony Evans, President of the National Black Church Initiative says, “I’m only going to say this once. If you are a black person from Charm city and you are criticizing this sister because she is fighting against wickedness in high places and principalities then you are playing into the hands of the white racist who wants you to hate the people that actually defend you. This sister is already a hero because she had the power and the gumption to bring charges against black and white officers who killed our brother Freddie Gray. So 34,000 churches is sending a message to whoever wishes harm to this woman and her staff. Take your hands off this woman or we will pray that God moves against you. Sister Mosby, the Black Church has got your back. Keep on doing what you need to get done. God will come to your rescue.”

Our fight is not with sister Mosby, our fight is with the Maryland fraternal order of police who abuse their authority by pulling us over for no good reason other than the fact that they want to demonstrate that they have been given unbridled power to do what they want. For those who wish this sister any harm, who are praying and who are using unethical and illegal tactics for her to lose these cases, including Judge Williams, the Black Church has a message for you and our message is that God sees you and He will punish you ten times greater than what you are doing to this sister.

We clearly understand that Judge Williams has an agenda. He wants to be known as the Negro who doesn’t consider himself black until he gets pulled over himself for driving while black. What Judge Williams needs to understand is that no matter how hard he is on the Prosecution on every detail of this case as if he is bending over backwards to be fair, the same white officer who pulls him over will not grant him that courtesy. Even when he is appointed to the State Supreme Court or to the Federal Bench.

For that white racist Maryland police officer pulls black folks over, not because he is concerned about the public safety, only because he hates black people that much and he can.
