## National Black Church Initiative Calls for the Creation of a 25 Million Dollar Fund to Help Combat Police Brutality in the African American Community

## No Peace without Justice

**Washington, DC** – The National Black Church Initiative (NBCI), a faith-based coalition of 34,000 churches comprised of 15 denominations and 15.7 million African Americans calls for the creation of a 25 million dollar fund to help combat police brutality in the African American community. Given the horrific incidents that have happened to African Americans from the Bland case, Trayvon Martin, Eric Garner and Michael Brown, clearly underscores that the black community in 2015 can no longer trust law enforcement for justice. The late Attorney Johnny Cochran encouraged the public to exercise its citizenship rights and *police the police* to ensure social justice and fairness are experienced regardless of status and stature in the community.

The purpose of the fund is to be able to hire investigators to verify the evidentiary findings of the police as well as challenge any emerging suspicions related to those findings in the court of law. For the first time, this will give the black community the ability and access to respond scientifically and systematically to questionable evidence involving African Americans within the court of law. This targeted initiative is why the innocent project headed by Berry Shack has been able to exonerate over 100 African American males on death row. Similarly, this will allow us to create innovative investigative techniques to finally close cold cases of loved ones in our community.

Rev. Anthony Evans, President of the National Black Church Initiative, says "we must do something bold using a strategic and results-oriented approach to eradicate disparities of justice."
