(NBCI), a coalition of 150,000 African American and Latino faith communities representing 27.7 million members, has requested that the U.S. Attorney's Office investigate the missing \$10 million scandal involving the Hope program. We now have one aim in our country, coming out of the most prolonged government shutdown in history, and trying to feed 45 million people who are food-insecure. Those \$10 million could have gone a long way in addressing the nutritional needs of families in Florida and across the nation.

This scandal does not sit well with many nonprofits across the nation, whereas we are being asked more and more to tackle the government with nothing but straws. The Hope Program is designed to connect eligible residents with churches and other charities across Florida that offer alternative services intended to replace cash assistance programs, and also awards cash grants to organizations supporting similar causes. The State Department of Children and Families oversees the logistics for the project, and the agency also created a nonprofit foundation to handle fundraising and grants privately.
